**Kendall County Farm Bureau Foundation
Scholarship Policies**

1. Scholarship funds will be awarded to the student. Scholarships can be used for fall, spring, or summer semester tuition during the school year immediately following the individual's selection as a scholarship winner or may be used for room, board, books or course supplies and fees. If the student does not use the scholarship within the year, the scholarship is forfeited. The student can, however, re-apply for a scholarship with the Kendall County Farm Bureau Foundation in ensuing years as long as the person meets the application criteria.
2. Foundation Scholarship recipients can be full time or part-time students, attending an accredited two or four-year College, university or vocational-technical school.
3. The overall purpose of the KCFB Foundation's Scholarship program is to provide financial assistance to members and dependents. The program is designed to encourage our recipients to come back to agriculture and strengthen its' future. The program is not designed to be strictly a financial aid program for members.
4. The Board of Directors selects the recipients soon after the application deadline. In evaluating the application, the committee will ensure applicants first meet all of the eligibility requirements and then consider the content of the application.
